### THE JESUS WAY

We have been talking and trying restorative justice practices at Abbotsford Christian School over the past year. We had a significant issue which we sorted through last fall using restorative practices. Much of our motivation was garnered from the inspiring work that Mark Nill has done for many years with his team at Surrey Christian School. We are compelled to think that these methods are more consistent with "The Jesus Way" than traditional approaches to discipline. Many people don't know what these principles encompass so it is probably worth exploring a summary (some of this is taken from the Abbotsford RJ Association).

The early experiments in Restorative Justice in Canada were initiated by individuals embracing a Christian worldview.

Accordingly, Christian values find their place in Restorative Justice. Some of these values are peacemaking, reconciliation, forgiveness, care and support for one another within a context of community, personal responsibility and accountability to one another. Restorative Justice practices are especially effective with regards to wrongdoing and restoration of the wrongdoer who is remorseful and willing to change his/her ways. These values are not unique to a Christian worldview, but the Restorative Justice movement has certainly been encouraged and fostered by individuals and groups who identify themselves with a biblical perspective.

Two of the values that resonate especially well with traditional Christian thought are reconciliation and forgiveness. Restorative Justice, though not specifically Christian in its premise, strives to bring reconciliation between the affected parties, working to provide healing and closure for all participants. Sometimes resolution is possible without reconciliation, but greater satisfaction is experienced when the affected parties can achieve reconciliation with one another. Similarly, some of the most spectacular results in Restorative Justice have been achieved when the victims have been provided with what they have needed, to be able to find inner healing and forgiveness toward the offender.

Restorative Justice holds in balance these two needs:

- 1. To identify wrongdoing as such, and hold accountable those who have perpetrated the wrong
- 2. To allow for reparation of harm, restitution, and amends, and the healing of broken relationships through exploration of thoughts and feelings, so that forgiveness can take place.

Restorative Justice also harnesses the energies of the community to meet the needs of both victims and offenders, not stigmatizing either of them, but providing them the help they each need to move on in dignity. This resonates with concepts of fellowship and care within Christian community as expressed throughout the New Testament.

Many Christian leaders are willing to commit to the hard work of repairing brokenness in our communities. We know that we will not always be one hundred percent successful, but we want to have the courage to use methods which give us the potential to restore relationships which have been harmed by sin. Please continue to pray for wisdom as each leader guides their community toward faithfulness, truth and grace.



### NEW MENTORSHIP PROGRAM – SCSBC/CPABC COLLABORATION

Our plans for the mentorship program are made up of four strategic parts – serve, learn, collaborate and transform. The experiences of our leaders over years of service are invaluable resources for future leaders. We know that we need a vehicle to transport this information to the next generation of leaders. We hope to see experienced administrators serving new leaders by developing intentional relationships which guide toward faithful, competent and servant-based leadership in our schools. Learning occurs through many different methods, but perhaps one of the greatest methods for learning about leadership is through relationships. There is great value in studying materials together. We have a list of leadership books and we suggest our participants will choose one to three books to study together and discuss the implications of their learning. Part of the relationship will be a chance to collaborate on projects which are ongoing in each other's schools. Finally, we hope for transformation in both directions as we utilize our gifts to exchange wisdom and build stronger Christian schools in the process.

In a nutshell, the plan for the program consists of:

- establishing learning targets in the application process
- regular SKYPE or coffee shop half-hour meetings as it best fits the partners' schedules
- two separate one-day visits to the mentor / mentee's schools for shadowing
- one to three books to be read and be discussed together (books are selected by the partners from the mentor / mentee list)
- one CPABC spring conference to be attended together where the partners spend some intentional time together
- a reflection report to be submitted (just a few paragraphs) for the CPABC newsletter or a
  presentation made at a spring conference so that the membership can see the impact of these
  relationships
- an online evaluation of the program to be completed at the end of the program

We hope to provide the rest of the details for this program at the spring 2013 conference and have a kick-off with Walter Wright at our fall conference.
